Erates Registration

By submitting this application you,

- 1. Confirm you are the registered owner, or registered ratepayer of the property address or have FULL third party authorisation to act on behalf of the owner/s.

- 7. Agree an *"out of office"* notification will not be considered an undeliverable rate notice.
- 8. Agree you are responsible for regularly checking your nominated email address for rate notices, including any junk folders.
- 9. Acknowledge if the City receives an electronic *"delivery failure"* notification from your nominated email address, your email delivery service will be cancelled and a paper copy of a rates notice will be posted to the last advised postal address.
