

### PROOF OF STERILISATION EXEMPTION

Proof of sterilisation is required in the form of either:

- · Veterinary Surgeon's Certificate (please attach photocopy)
- · Exemption for sterilisation or microchip from Vet
- Ranger sighting ear tattoo
- Contact information for responsible Vet Clinic

### APPLICATION FOR APPROVED BREEDER

You are considered a cat breeder if you wish to breed a litter from your cat. If a are a current car breeder or wish to become a breeder, you must apply for a cat breeding permit. These permits are valid for 12 months and a Property Inspection is required. To be an approved breeder a fee and 1 year registration must be paid.

### CAT OWNER'S RESPONSIBILITIES

The Cat Act 2011 & the Cat Local Laws state that cat owners must ensure their cat:

- Wears a collar and a registration tag when in a public place
- All cats ages six months and over must be registered, sterillised and micro chipped (Cat Act 2011)
- Approved breeders must have suitable premises where cats can be bred in a safe & ethical way
- Only two cats permitted per property unless granted an exemption by the city
- Cats must be kept indoors between 8pm-6am

Your registration fees;

- Reunites lost cats with their owners.
- Contributes to the maintence of the Animal Management Facility
- Supports Ranger Services with the City of Kalgoorlie-Boulder
- Cat registrations must be renewed prior to 1st November
- The City must be informed immediately of any change of details (i.e. deceased, ownership, address etc).
- Reduced fees apply upon proof of either current Pensioners Concession Card or Commonwealth Seniors Health Card with a WA Seniors Card.
